This Addendum amends the parties' Software License Agreement accompanying the Allegro CL acquired by Licensee ("Software License Agreement") to provide Licensee the following rights and obligations with respect to the above-referenced source code modules ("Licensed Source Code") and support for the licensed copy of Allegro CL or Add-On. Licensee and Franz Inc. agree that the Software License Agreement constitutes the parties' agreement with respect to Allegro CL and/or Add-On, as applicable to Licensee, and, except as set forth herein, shall be and remain unmodified and in full force and effect.

# 1. License Grant.

- (a) Subject to the terms and conditions of this Addendum, Franz Inc. grants to Licensee, a limited, non-exclusive, non-transferable, license, with no right to sublicense:
  - (i) to use and modify the Licensed Source Code, in the country in which Licensee has its principal offices or headquarters, but only if this country is not or is not located in a country currently under economic and trade sanctions (as outlined by The Office of Foreign Assets Control ("OFAC") of the U.S. Department of the Treasury), only at the above specified location (or a substitute location on prior written notice to Franz Inc. identifying the location) only in support of Licensee's authorized use of Allegro CL or Add-On licensed to Licensee pursuant to the Software License Agreement and subject to the restrictions set forth in the Software License Agreement and below; and
  - (ii) to compile and create binary versions (the "Binary Versions") of Licensed Source Code, or modified Licensed Source Code, that are (A) created pursuant to Section 1(a)(i) above, and (B) compiled in accordance with Section 2(a) below. Licensee's right with respect to Binary Versions shall be, and shall be limited to, those rights granted to Licensee with respect to Allegro CL or Add-On, as applicable, in the Software License Agreement.

(b) No licenses are granted by implication or estoppel, or otherwise except for the express licenses granted herein. All licenses and rights not expressly granted to Licensee are retained by Franz Inc.

## 2. Additional Licensed Source Code Restrictions.

- (a) Licensed Source Code, and modified Licensed Source Code, may be compiled only with Franz Inc. compilers licensed by Licensee from Franz Inc.
- (b) No right is granted to reproduce, disclose, or distribute any Licensed Source Code or modified Licensed Source Code in source code form. Licensee's distribution rights, if any, with respect to Binary Versions shall be as set forth in the Software License Agreement.
- (c) Licensee may copy the Licensed Source Code and modified Licensed Source Code only as necessary for backup or archival purposes, in machine readable form only, and each such copy of the Licensed Source Code and modified Licensed Source Code shall be marked as an archival or backup copy and as the confidential and proprietary property of Franz Inc.
- (d) Licensee shall not remove or alter restrictive legends, copyright notices, government notices, or other notices appearing on or in the Licensed Source Code, and shall reproduce all such notices on each copy of the Licensed Source Code and modified Licensed Source Code.

## 3. Ownership.

Licensee acknowledges and agrees that all right, title and interest to the Licensed Source Code belongs to Franz Inc. All modifications to Licensed Source Code prepared by Licensee, whether compiled, binary or otherwise, shall be owned by Licensee as a derivative work subject to Franz Inc.'s rights in the underlying code. The parties understand and agree that Licensee may from time to time disclose modified Licensed Source Code, and information pertaining to such code, to Franz Inc. Unless otherwise specified by Licensee and agreed to by Franz in writing, at the time of such disclosure, Licensee agrees that Franz Inc. may reproduce, use, modify and distribute, and authorize third parties to reproduce, use, modify and distribute, such code or information for any purpose.

## 4. Delivery.

Upon receipt of and execution by Franz Inc. of a copy of this Addendum executed by Licensee, Franz Inc. shall deliver license keys to the Licensed Source Code to Licensee. Franz Inc.'s delivery to Licensee, and Licensee's retrieval of such license keys for the Licensed Source Code shall be evidence to Licensee that Franz Inc. has executed this Addendum.

# 5. Patent, Copyright, and Trade Secret Indemnification.

Franz Inc. disclaims any, and shall have no, obligation of defense or indemnity of Licensee or its direct and indirect customers with respect to any actual or alleged patent, copyright, trade secret, or other intellectual property right, infringement with respect to Licensed Source Code, modified Licensed Source Code, or distribution of Binary Versions, or otherwise arising out of this Addendum. Licensee, however, shall provide to Franz Inc. prompt written notice of any claim or action alleging such infringement, or any infringement by Allegro CL or Add-On.

## 6. Source Code Support and Maintenance.

Notwithstanding the provisions in Section 9 below regarding object code software, Franz Inc. shall not be obligated to provide any support or maintenance for Licensed Source Code.

#### 7. Warranty Disclaimer.

NOTWITHSTANDING ANY WARRANTY GIVEN BY FRANZ INC. IN THE SOFTWARE LICENSE AGREEMENT, THE LICENSED SOURCE CODE IS PROVIDED "AS IS," AND FRANZ INC. GRANTS NO WARRANTIES, EXPRESS, IMPLIES, STATUTORY OR OTHERWISE, REGARDING THE LICENSED SOURCE CODE, AND EXPRESSLY DISCLAIMS ANY IMPLIED WARRANTIES OR MERCHANTABILITY, NONINFRINGEMENT, AND FITNESS FOR A PARTICULAR PURPOSE.

#### 8. Confidentiality.

- (a) Licensee agrees to retain the Licensed Source Code in strict confidence and shall use such code and information only as authorized herein. Licensee agrees that it will under no circumstance in any way (i) disseminate or disclose any Licensed Source Code, or the information or ideas contained therein, or (ii) use the Licensed Source Code, or the information or ideas contained therein, except as authorized herein, without the prior express written permission of Franz Inc.
- (b) Access to the Licensed Source Code shall be restricted to Licensee employees with a need for such access for the purposes authorized in this Agreement. No copy of the Licensed Software Source Code shall be permitted off Licensee's business location as noted above.

(c) Licensee's compliance with this section is essential to this Addendum and a condition of Licensee's possession, use, and modification of the Licensed Source Code.

# 9. Support and Maintenance.

- (a) Upon receipt of this Addendum signed by an authorized employee of Licensee, until one (1) year from Licensee's date of purchase of the license for the licensed object code copy of Allegro CL or Add-On, Franz Inc. will provide support and maintenance for that copy, as described in Section 9(b) below..
- (b) Franz Inc. will offer reasonable consultation, via telephone, telecopy, electronic mail or other writing, on specific problems that arise in the installation and use of Allegro CL or Add-On. Franz Inc. may provide bug fixes and updated releases to Licensee from time to time as such are customarily provided to licensees of Allegro CL or Add-On. Notwithstanding the above, Franz Inc. does not guarantee consultation results nor represent or warrant that errors or bugs will be corrected. The above-described support and maintenance will be provided only for the most current release of Allegro CL or Add-On. This does not include any such support for modifications or additions by Licensee.
- (c) All bug fixes, updates, and other software provided by Franz Inc. shall be deemed part of Allegro CL or Add-On and subject to the Software License Agreement accompanying Allegro CL or Add-On. Any source code provided shall be subject to this Addendum.
- (d) For additional support and maintenance of the most current release of an Allegro CL or Add-On. Licensee shall pay to Franz Inc. its standard annual maintenance fee as set forth in the applicable Franz Inc. Marketing and Sales Policy (currently 25% of the list prices of Allegro CL or Add-On) no later than thirty (30) days prior to the beginning of any year during which such support and maintenance are to be provided.
- (e) The parties understand and agree that in order for Franz Inc. to perform its obligations under this Agreement or for other purposes pertaining to Allegro CL or Add-On generally, Franz Inc. may, from time to time, request, receive and use certain computer code and other information from Licensee with respect to Allegro CL or Add-On. Unless otherwise specified by Licensee and agreed to by Franz Inc., in writing, at the time of disclosure of such code or information, Licensee agrees that Franz Inc. may reproduce, modify, use and distribute, and authorize third parties to reproduce, modify, use and distribute, such code of information for any purposes, including, without limitation, in or with respect to test suites for Allegro CL or Add-On.

## 10. Term and Termination.

- (a) Licensee or Franz Inc. may terminate this Addendum separately from the Software License Agreement upon any default of this Addendum.
- (b) This Addendum shall terminate automatically upon termination of Licensee's Allegro CL or Add-On object code license pursuant to the Software License Agreement.
- (c) Upon termination of this Addendum, Licensee shall promptly return to Franz Inc. all Licensed Source Code and all other materials provided by Franz pursuant to this Addendum, and all partial or complete copies thereof, or shall destroy all such items and provide to Franz a written certification, signed by an officer of Licensee, of such destruction.
